# **Important information during COVID-19:**

- Will County Court Personnel still assisting walk-ins with Protective Orders
- However, if possible, it may be helpful to complete as much of the Petition online as possible before arriving at Will County Courthouse to limit exposure to others.
- Once you start a Petition online, you will receive a receipt number at the beginning of the process. This number should be kept in a safe location and allows you to start, stop and continue completing the petition as needed.
- Due to COVID-19, Will County Court Personnel are assisting people seeking protective orders from behind a glass window on the 2<sup>nd</sup> floor of the Courthouse. Please be aware privacy may be limited.
